

The Times of Your Life Contest

OFFICIAL RULES

NO PURCHASE NECESSARY

1. ENTRY PROCESS:

To participate in the “Times Of Your Life” contest, go to www.SAWomensHealth.net and submit your entry. Monthly winners will be chosen from among the most highly-rated submissions for January and February 2008 combined, March 2008 and April 2008. All entries must be submitted no later than midnight on the last day of each month in order to qualify for that month’s eligibility and voting. Accepted entries received after the last day of the month, will automatically become eligible for the following month’s selections, if the competition continues the next month. Not responsible for lost, late, incompatible files or multiple entries or the outcomes of open, public voting.

On-line public voting for the monthly submissions will continue at www.SAWomensHealth.net until on or about April 30, 2008 from among all eligible postings received within the specified entry period. Odds of winning will depend upon the number of eligible entries submitted and random public opinion voting. All submissions become the property of Methodist Healthcare System and will be screened for appropriate subject matter prior to public Internet visibility. Only one contest vote accepted from any individual/email address within each 24-hour day.

Charities selected by winners, as designated recipients, must be registered 501(c)(3) organizations and recognized by the United States Internal Revenue Service as non-profit organizations willing to submit all substantiating documentation required for receipt of qualifying donations. Selected organizations must also agree to the inclusion of their name(s), symbol(s), logo(s), local personnel and operations (if any) in connection with the promotion of prize awards in selected print and electronic media outlets.
